NOTICE IS HEREBY GIVEN that the Board of Directors (the "Board") of Murata Farms Commercial Metropolitan District (the "District"), City of Fort Lupton, County of Weld, State of Colorado, will hold a special meeting at 1:00 PM on Monday, February 7, 2022. At this meeting it is anticipated that the Board will make a final determination to issue or incur general obligation indebtedness via the execution and delivery of a Capital Pledge Agreement to be entered into with Murata Farms Residential Metropolitan District and a bond trustee. Specifically, the District will consider adoption of a resolution authorizing the incurrence of general obligation indebtedness in connection with bonds to be issued by Murata Farms Residential Metropolitan District, of its General Obligation Limited Tax Bonds, Series 2022(3). The District intends to make a final determination to issue or incur such general obligation indebtedness in the form of the Capital Pledge Agreement in a maximum aggregate principal amount not to exceed \$13,000,000 for the purpose of (a) paying or reimbursing the costs of public improvements for the District, and (b) paying costs of issuance. It is anticipated that the resolution will also authorize the execution and delivery of any other documents necessary or appropriate in connection with the incurrence of the foregoing general obligation indebtedness.

Pursuant to the Supplemental Public Securities Act, (i) no legal or equitable action brought with respect to any legislative acts or proceedings in connection with the authorization or issuance of the indebtedness may be commenced more than thirty days after the authorization of such indebtedness pursuant to the aforementioned resolution, and (ii) one or more members of the Board may participate in this meeting and may vote on the foregoing matters through the use of a conference telephone or other telecommunications device."

The Board will also take up such other business as may come before the Board. The meeting is open to the public.
